Trustee Abbott made a motion, seconded by Trustee Christensen to open the Budget Workshop Meeting. All in favor; motion carried.

VILLAGE BUDGETS

Mayor Brazill stated the purpose of the meeting is to work on the Village Budgets for the 2024-2025 Fiscal Year.

**REVIEW OF BUDGETS** 

Mayor Brazill and the Village Board reviewed the following areas associated with the

## **Sewer Fund Budget**

- Purchase of new or used 10-wheeler truck and F250
- Infrastructure Repairs
- Capital Improvement Project 2022 Plant Renovations/Upgrades
- Sale of old equipment/vehicles
- 1st principal payment for \$2.4m BAN

## Tax Cap Limit

Village board reviewed the assessed taxable value of properties, calculated at the current tax rate of \$9.23/thousand will generate \$2,298,110.96 in property tax revenue. The tax levy limit for 2024-25 budget is \$2,039,621.00. A discussion ensued on the subject of adjusting the tax rate in order to decrease the amount over the tax cap limit.

Schedule public hearing for Local Law #1 for 2024 to override the tax levy limit established in General Municipal Law 3-c.

Clerk DeVona presented a draft copy of Local Law #1 for 2024 to the board for consideration and to schedule a public hearing.

Trustee Christensen made a motion, seconded by Trustee Champagne to schedule a public hearing on March 18, 2024 at 6:30pm for Local Law #1 for 2024 to override the tax levy limit established in General Municipal Law 3-c. All in favor; motion carried.

- Fire Department increase A3410.49 to accommodate replacement of parking lot at FS2 and new security cameras
