RESOLUTION RECOGNIZING TEAMSTERS LOCAL 317 FOR CERTAIN EMPLOYEES

RESOLUTION RECOGNIZING TEAMSTERS LOCAL 317 AS EXCLUSIVE BARGAINING REPRESETNATIVE FOR CERTAIN EMPLOYEES OF THE DEPARTMENT OF PUBLIC WORKS

The following resolution was offered by Trustee Champagne, who moved its adoption, and second by Trustee Christensen to wit:

WHEREAS, by a letter dated July 25, 2019, Teamsters Local 317 [the "Union"] initially requested that the Village of Minoa ["Village"] voluntarily recognize it as the exclusive collective bargaining representative for certain job classifications within the Village's Department of Public Works (the "proposed bargaining unit"); and

WHEREAS, the Union represented that a majority of the employees in such job classifications, as defined herein, desire such representation by the Union; and

WHEREAS, the Union and Village subsequently agreed on a procedure for determining if the majority of bargaining unit employees desire Union representation, and proof of such majority status was certified by PERB ALJ Rita A. Strauss on January 29, 2020; and

NOW, THEREFORE, BE IT RESOLVED, that the Village hereby adopts this resolution to voluntarily recognize the Union as the collective bargaining representative for the proposed bargaining unit, based upon the certification of a showing of majority status; and

BE IT FURTHER RESOLVED, that the proposed bargaining unit consists of all full-time employees in the job classifications of Laborer 1 and Automotive Mechanic employed within the Department of Public Works, excluding part-time laborers and all other Village employees; and

BE IT FURTHER RESOLVED, that this voluntary recognition is subject to and conditioned upon the withdrawal of the Union's pending petition

and/or representation proceeding that is presently pending before the New York State Public Employment Relations Board in Case No. C-6570.
