DISCUSSION: ESTABLISH AMBULANCE RESERVE

A discussion took place regarding establishing a reserve fund for ambulance department. Mayor Brazill asked that the village attorney draft a resolution similar to the resolution adopting the Minoa Fire Station II reserve for board review.

DISCUSSION – EXCESS LIABILITY COVERAGE: OCCURANCE/AGGREGATE LIMITS

A discussion took place regarding the liability limits of village coverage for the Town of Manlius Fire Protection Contract for 2019. The fire contract is requiring Excess Liability \$3Million each occurrence/\$5Million aggregate and the village only has \$1Million each occurrence / \$3Million aggregate and additional there is a provision in the contract that states if village does not have enough insurance coverage we would still be liable for up to the \$5Million amount. The village board reviewed the insurance quotes received from their agent and asked that the Clerk request a quote for \$4Million each occurrence / \$4Million Aggregate and ask if the umbrella is considered in this equation.
