PUBLIC HEARING LL #1 OF 2024

PUBLIC HEARING FOR LL#1 OF 2024 – Chapter 67 "Fire Department"

Trustee Champagne made a motion, seconded by Trustee Christensen to waive the reading of legal notice and open the public hearing for LL#1 of 2024, Amending Chapter 67 entitled "Fire Department" specifically the regulations applicable to the approval of the Bylaws of the Fire Company. All in favor; motion carried.

Mayor Brazill opened the public hearing at 6:34pm.

Attorney Hill stated this amendment relates to the reassigned responsibilities of the village and the Minoa Fire Department, Inc Executive Board and Membership therefore changes to Chapter 67 are necessary.

With no questions from the board or those present, Trustee Christensen made a motion, seconded by Trustee Abbott to close the public hearing. All in favor; motion carried.

Trustee Schepp made a motion, seconded by Trustee Champagne to adopt LL #1 of 2024 amending Chapter 67 entitled "Fire Department. All in favor; motion carried.

PUBLIC HEARING FOR LL#2 OF 2024 – Building Construction and Fire Prevention

Trustee Christensen made a motion, seconded by Trustee Champagne to waive the reading of legal notice and open the public hearing for LL#2 of 2024, Amending Chapter 51 entitled "Building Construction and Fire Prevention" specifically the regulations applicable to the expiration of building permits. All in favor; motion carried.

MANDATORY REFERENDUM RESOLTUION

MINOA FIREMAN SERVICE AWARDS PROGRAM (LOSAP)

The following resolution was offered by Trustee Schepp, who moved its adoption, and second by Trustee Christensen to wit:

WHEREAS, in 1988, in order to help municipalities recruit and retain volunteer firefighters, New York State enacted Article 11-A of the General Municipal Law, authorizing the establishment of Length of Service Award Programs for the benefit of volunteer firefighters who annually meet certain point totals based on participation in department activities; and

WHEREAS, on March 6, 1990, the Village of Minoa Board of Trustees ("Village Board"), with voter approval, established a Length of Service Award Program for the Volunteer Firemen of the Village of Minoa ("Service Award Program"), providing for service benefits to its volunteer members in accordance with the terms of the approved contribution plan approved by duly adopted resolution of the Village Board on January 16, 1990; and

WHEREAS, Section 216(3)(e) of the General Municipal Law provides that, except in limited circumstances, a Service Award Program, once established, may only be amended prospectively, and then only subject to mandatory referendum; and

WHEREAS, the Village Board deems it to be in the best interests of the Village of Minoa and the residents served by the Minoa Fire Department to amend its Service Award Program as outlined in the draft attached hereto as Schedule "A" and made a part hereof; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND DETERMINED, that the Village Board, by an affirmative vote of at least sixty percent (60%) of the Village Board, hereby approves an amendment to the Service Award Program for the Volunteer Firemen of the Village of Minoa, as outlined in Schedule "A"; and it is

FURTHER RESOLVED, that the next General Election shall be held on Tuesday, March 19, 2024; and it is further

FURTHER RESOLVED, that the polling place for said election shall be at the municipal building, 240 N. Main Street, Minoa, New York 13116; and

FURTHER RESOLVED, that the proposition to be voted upon at said election shall read as follows: "Shall the Village of Minoa amend its Service Award Program for the Volunteer Firemen of the Village of Minoa, providing that in the event an active or active life member opts to commit to a 12-hour Duty Crew schedule (12 hours per week minimum of 44 shifts or 528 hours annually), it shall NOT be mandatory for that member to fulfill the requirements of the Mandatory Participation in the Department Responses Section of the Point System Guidelines?"

FURTHER RESOLVED, that no later than ten (10) days before said election a summary of this Resolution shall be published once in the Village's designated official newspaper of general circulation, and that a copy of same shall be posted in at least six (6) conspicuous places in the Village of Minoa, New York;
