JUSTICE COURT

RESOLUTION ABOLISHING OFFICE OF VILLAGE JUSTICE

The following resolution was offered by Trustee John Champagne, who moved its adoption, and second by Trustee Robert Schepp to wit:

WHEREAS, pursuant to Section 3-301(2)(a) of the Village Law of the State of New York, the Village of Minoa Board of Trustees ("<u>Village Board</u>") may, by resolution subject to permissive referendum, abolish the office of Village Justice to take effect upon the expiration of the current term of such office; and

WHEREAS, the Village Board has investigated the effectiveness and has considered the financial prudence of abolishing said office and those resultant from the Town Justice(s) assuming the functions previously performed by the Village Justice; and

WHEREAS, the Village Board finds that the needs of the Village for the prosecution of violations under the Village of Minoa Code can be handled effectively by the Town Court; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND

DETERMINED, that the Office of Village Justice be, and the same hereby is, abolished upon the expiration of the current term ending on March 31, 2026, subject to the Village of Minoa and the Town of Manlius entering into an Intermunicipal Agreement for the disposition of revenue generated by the Office of Village Justice, and for the maintenance of records and completion of reporting requirements upon abolishment of the office, said agreement to be approved by the respective boards of the Village and Town on or before the thirtieth (30) day after adoption of this Resolution; and it is

FURTHER RESOLVED, that this Resolution is adopted subject to permissive referendum, and the Village Clerk is hereby authorized and directed to publish and post notice of such adoption in accordance with law; and it is further

FURTHER RESOLVED, that this Resolution will be effective upon the date of the expiration of the period for the referendum, or upon a referendum vote supporting the abolition of the office of the Village Justice; Upon Roll Call Vote:

WHEREAS, the Village of Minoa

herein called the "Municipality", after thorough consideration of the various aspects of the problem and consideration of available information, has hereby determined that certain work, as described in Attachment A, herein called the "Project", is desirable, is in the public interest, and is required to implement the Project; and

WHEREAS, the Central New York Regional Planning & Development Board, herein called the "Board", has provided program planning and implementation assistance pertaining to the requirements of the New York State Pollutant Discharge Elimination System (SPDES) Stormwater Phase II General Permit for Municipal Separate Storm Sewer System (MS4) operators since 2002, and

WHEREAS, the Board has proposed staff and education assistance services in support of sustaining the CNY Stormwater Coalition and to provide a regional public education, outreach and training compliance program to reduce municipal staff burdens, ensure consistency, provide widespread priority audience targeting the most efficient use of limited municipal funds by distributing total program costs over a number of entities within a twelve-month timeframe.

NOW, THEREFORE, BE IT RESOLVED BY the Village of Minoa Board of Trustees:

- 2. That the Municipality agrees that it will fund its portion of the program cost in the amount of \$3,600, and that those funds will be made available to the Board upon receipt of invoice.
- 3. That one (1) certified copy of this Resolution will be prepared and sent to the Board upon adoption.
 - 4. That this Resolution take effect immediately.
