Trustee Champagne made a motion, seconded by Trustee Abbott to waive the reading of legal notice and open public hearing. All in favor; motion carried

Mayor Brazill opened the public hearing at 6:35pm. .

Mayor Brazill stated the village will present the following Five (5) Year Plan for Sidewalk Replacement to Onondaga County Community Development for consideration in the 2019 Funding cycle:

Five-Year Plan

Year One

Concrete Sidewalk installation – North Main Street (East side) between Osborne Street & East Avenue

Flexible Porous Pavement Installation Rear Entrance of Village Hall

Year Two

Concrete Sidewalk installation – Elm Street between Edgerton & Willard (East Side)

Year Three

Concrete Sidewalk installation – Elm Street between Edgerton & Willard (West Side)

Year Four

Concrete Sidewalk installation – Elm Street between Willard & North Central (East side)

Year Five

Concrete Sidewalk installation – Elm Street between Willard & North Central (West side)

Estimated Project Cost – approximately \$174,950.00

*Each of the above sections of sidewalk can be phased out over five (5) year plan. Submission can be customized recognizing the demand for money and grant funding available.

With no questions or comments with the Five (5) Year Plan, Trustee Champagne made a motion, seconded by Trustee Abbott to close the public hearing.

INTERMUNICIPAL AGREEMENT WITH BOARD OF COOPERATIVE EDUCATIONAL SERVICES (BOCES) FOR TECHNOLOGY SERVICES THROUGH REGIONAL INFORMATION CENTER

Trustee Champagne made a motion, seconded by Trustee Abbott authorizing the Mayor to execute Intermunicipal Agreement with Board of Cooperative Educational Services (BOCES) for Technology Services through Regional Information Center for period June 1, 2019 through May 31, 2020 contingent upon village insurance agent review. All in favor; motion carried.

2019-2020 WORKERS COMPENSATION RENEWAL - COMP ALLIANCE

Trustee Abbott made a motion, seconded by Trustee Champagne accepting the renewal rate of \$120,584 for Workers Compensation coverage with Comp Alliance, June 1, 2019 through May 31, 2020. All in favor; motion carried.

DISCUSSION - RESIDENTIAL TO COMMERCIAL ZONE S. MAIN STREET

A discussion ensued regarding properties located on S. Main Street across from Lewis Park, from the corner of Hulbert Street to S. Central Avenue. Mayor Brazill stated he recently met with Dan Kwasnowski, Planning Director for Onondaga County to discuss the County Plan and conceptual themes for a new comprehensive plan. One of the county goals is to develop

planning projects with local municipalities and help find the funding resources necessary to carry out the projects.

Mayor Brazill stated commercial properties currently exist along North Main Street from East Avenue to the pedestrian railroad crossing (green bridge) at the corner of North Central Avenue continuing on the other side of the bridge to South Central Avenue. South Main Street from South Central Avenue to Hulbert Street is residential zoning until the corner of Hulbert Street and Costello Parkway. The board is considering changing the residential zoned properties along S. Main Street, approximately fourteen (14) parcels, to commercial. Connecting the commercial zones (North and South) would create a corridor offering a residential and commercial mix use capabilities possibly attracting new residents, new businesses and funding opportunities. Lewis Park events such as Friday night car show, Hope for Heather 5K Race, Minoa Fireman's Field Days, Fall Festival, and for the first time this year the CNY Bavarian Oktoberfest are attracting more and more visitors to our community.

Trustee Abbott made a motion, seconded by Trustee Champagne to schedule a public hearing for LL#2 for 2019 on June 3, 2019 beginning at 6:31pm. All in favor; motion carried.

DISCUSSION - TRAFFIC AND SPEED - BERESFORD LANE

Mayor Brazill stated he has been approached by many property owners along Beresford Lane with concerns for public safety of the children and adults that walk and bike in the area. Mayor Brazill asked the board members for their thoughts on additional stop signs or reducing the speed on Beresford Lane. Trustee Rinaldi suggested increasing the police presence in the neighborhood, Trustees Abbott and Champagne stated they were against lowering the speed limit; they believe 25mph is low enough.

Mayor Brazill stated he would reach out to the Town of Manlius Police Department to request a traffic control device/tracker be placed on Beresford Lane and the board can review the data after it is collected.

MUNICIPAL BUILDING SECURITY

Trustee Champagne made a motion, seconded by Trustee Abbott to approve CNY Security Solutions \$5,000 estimate to upgrade the security cameras and monitoring system in the Municipal Building. All in favor; motion carried.

Trustee Champagne stated the estimate is to increase the number of cameras in the building and upgrade the ten year old system.
