MINOA FARMS, SECTION 2A UPDATE

Mayor Brazill stated Village Engineer has inspected Phase 2A to verify current site conditions and to follow up on the February 2024 list of incomplete construction items. Village engineer found the majority of the unfinished items listed on the punch list have been unresolved for months and recommends that the village take appropriate action to compel the developer to finish the listed items and dedicate the infrastructure to the Village.

With no progress made on the unfinished punch list discussed at the last meeting, Trustee Christensen made a motion, seconded by Trustee Schepp to declare Brolex Properties, LLC and Oot Bros., Inc in default of the Subdivision Improvement (Maintenance) Guaranty Agreement dated March 3, 2021 and authorize the Codes Enforcement Officer to issue Stop Work Orders on Section 2A, and request developer respond within seven (7) business days; if request is not answered in seven (7) business days the Village Board will take next step and bid out the work for unfinished punch list and invoice the developer. All in favor; motion carried.


ATTORNEY REPORT
