The report is prepared each year by the Clerk's office with data from Code Enforcement, Department of Public Works and Waste Water Treatment Facility.

PUBIC HEARING ELECTION 2024

TO CONSIDER ONONDAGA COUNTY BOQA4RD OF ELECTIONS TO CONDUCT VILLAGE ELECTIONS IN MARCH

Trustee Christensen made a motion, seconded by Trustee Schepp to waive the reading of legal notice and open public hearing to consider adopting a resolution to allow Onondaga County Board of Elections to conduct future village elections. All in favor; motion carried.

Mayor Brazill opened the public hearing at 6:35pm

Mayor Brazill gave an overview of the options available to the village regarding future elections:

- Onondaga County BOE conducts village election in November, with no expense to the village
- Onondaga County BOE conducts Village elections in March, village will be charged for all costs
- Village conducts their own election with their own materials and voting equipment as the new machines purchased by Onondaga County BOE are not available to rent

With no questions from the board or the public, Trustee Christensen made a motion, seconded by Trustee Schepp to close the public hearing.

Mayor Brazill closed the public hearing at 6:37pm.

Trustee Christensen made a motion, seconded by Trustee Schepp to adopt the following resolution:

WHEREAS, the N.YS. Board of Elections voted August 2, 2023 to approve new voting machines for use in future elections that will allow for faster processing at the polls; and

WHEREAS, the Onondaga County Board of Elections (the "Onondaga County BOE") has chosen Clear Ballot Group as its new voting and election management systems vendor, which shall replace the current vendor that has been in place since the 2008 General Election, and voters will begin using the new machines this fall; and

WHEREAS, the Village of Minoa (the "<u>Village</u>") elections have historically been held on the third Tuesday in March and have been conducted and managed solely by the Village using paper ballots; and

WHEREAS, the Village Board of Trustees (the "Board of Trustees") discussed at length the option under New York Election Law Section 15-104(c) which provides that the board of trustees of a village may adopt a resolution, subject to a permissive referendum as provided in Article Nine of the New York State Village Law, providing that village elections shall be conducted by the board of elections, as a possible solution for more secure and efficient future Village elections; and

WHEREAS, a duly scheduled public hearing was held by the Village Board of Trustees this evening at which time residents of the Village had an opportunity to submit comments regarding the proposal to have the Onondaga County BOE conduct all future Village Elections; and

WHEREAS, following the public hearing, the Village Board of Trustees

determined that it would be in the best interest of the Village to have the Onondaga County BOE conduct all future Village Elections; and

NOW THEREFORE, BE IT RESOLVED, that the Village Board of Trustees hereby approves an agreement between the Village of Minoa and Onondaga County formally authorizing the Onondaga County Board of Elections to administer all future Village of Minoa elections using the County's equipment; and it is

FURTHER RESOLVED, that the Village of Minoa elections shall continue to occur in March, and that the Village shall be billed by the Onondaga County Board of Elections annually for the cost of administering said Village elections; and it is

FURTHER RESOLVED, that this Resolution is subject Permissive Referendum pursuant to the requirements of Article 9-900 of the New York State Village Law.

The adoption of the foregoing Resolution was moved by Trustee Eric Christensen, seconded by Trustee J. Robert (Bobby) Schepp, and duly put to vote, which resulted as follows:
