Pursuant to NYS Executive Order 202.2, issued May 1, 2020 all village elections schedule to take place in March, April, May and June of 2020 have been postponed and reschedule to September 15, 2020. The order also states that for any village election in which the ballot was fully determined when the election was postponed, the election will proceed with the same ballot.
